The purposes of this modification are to (1) extend the period of performance through September 30, 2009 with an additional five one-month options thru February 28, 2010, should the Government choose to exercise the options, (2) definitize CIS Request for Adjustment dated October 9, 2008, (3) increase the contract value to reflect the extension and definitization of the adjustment thereby increasing the FFP value in the amount of \$542,564 and the Maximum Potential IDIQ value in the amount of \$579,496; and (4) incrementally fund the contract pursuant to the Limitation of Funds Clause; The foregoing action is further implemented by the inclusion of the following changes:

(1) Clause 1a. entitled "FIRM FIXED PRICE (FFP), CONTRACT EXTENSION (EFFECTIVE SEPT. 1, 2006)", Paragraph (a) on Page 5 (Mod 70) is revised, as delineated on the revised Page 5 (Mod 71), to reflect the increase in the total firm-fixed price of the contract extension from \$11,730,677 by \$542,564 to \$12,273,241. Paragraph (b) on Page 5a (Mod 70) is revised, as delineated on the revised Page 5a (Mod 71) to reflect the following changes in the individual contract line item numbers (CLIN):

EX CLIN 1, 2, 3, 4: Period covered is changed from 8/31/2009; to 9/30/2009; Description is changed from (36 mos) to (37 mos) and FFP is changed from \$11,730,677 by \$542,564 to \$12,273,241 to reflect the one-month extension.

EX CLIN 11: Period covered is changed from 8/31/2009; to 9/30/2009; Description is change from (15 mos) to (16 mos); and FFP is changed from \$7,364,128 by \$542,564 to \$7,906,692 reflecting the one-month extension.

EX CLIN 6, 7, 8, 9, 10 and 12: Period covered is changed from 8/31/2009 to 9/30/2009; Description is changed from (36 mos) to (37 mos) and FFP is changed from \$13,417,093 by \$579,496 to \$13,996,589 to reflect summation of all task order extensions against H-34723D.

EX CLIN 12: Period covered is changed from 8/31/2009; to 9/30/2009; Description is change from (15 mos) to (16 mos); and FFP is changed from \$8,214,640 by \$579,496 to \$8,794,136 to reflect the one-month extension.

(2) Clause 2a. entitled "LIMITATION OF FUNDS (EFFECTIVE SEPT. 1, 2006)", Paragraph (a) on Page 8 (Mod 70) and Paragraph (c) on Page 9 (Mod 70) is revised, as delineated on the revised Pages 8 & 9 (Mod 71) to reflect incremental funding of \$1,476,000. Total Sum Allotted is increased from "\$27,693,089"; by \$1,476,000 to "\$29,169,089 the remaining balance is \$82,927"; Paragraph C on Page 9 changes from August 31, 2009 to September 30, 2009.

(3) Clause 3a. entitled "PERIOD OF PERFORMANCE, CONTRACT EXTENSION (EFFECTIVE SEPT. 1, 2006)", Paragraph (A) on Page 10 and Paragraph (B) on Page 11 (Mod 70) is revised, as delineated on the revised Page 10 and 11 (Mod 71), to reflect the extension of the period of performance from August 31, 2009 to September 30, 2009 with five 1-Month option should the Government choose to exercise the options.

(b) The Contractor agrees to perform or have performed work as specified in the PWS up to the point at which if this contract is terminated pursuant to the Termination for Convenience of the Government clause of this contract, the total amount payable by the Government (including amounts payable for subcontracts and settlement costs) pursuant to paragraphs (f) and (g) of that clause would, in the exercise of reasonable judgment by the Contractor, approximate the total amount at the time allotted to the contract. The Contractor is not obligated to continue performance of the work beyond that point.

3. (i) The notice shall state the estimated date when the point referred to in subparagraph (c) (1) above will be reached and the estimated amount of additional funds required to continue performance to the date specified in subparagraph (c) (1) above, or an agreed date substituted for it.

(ii) The Contractor shall, 60 days in advance of the date specified in subparagraph (c) (1) above, or an agreed date substituted for it, advise the Contracting Officer of the estimated amount of additional funds required for the timely performance of the contract for a further period as may be specified in the contract or otherwise agreed to by the parties.

4. If, after the notification referred to in subparagraph (c) (2) above, additional funds are not allotted by the date specified in subparagraph (c) (1) above, or an agreed date substituted for it, the Contracting Officer shall, upon the Contractor's written request, terminate this contract on that date or on the date set forth in the request, whichever is later, pursuant to the Termination for Convenience of the Government clause.

(d) When additional funds are allotted from time to time for continued performance of the work under this contract, the parties shall agree on the applicable period of contract performance to be covered by these funds. The provisions of paragraphs (a) and (c) above shall apply to the additional funds and the substituted date pertaining to them, and the contract shall be modified accordingly.

(e) If, solely by reason of the Government's failure to allot additional funds in amounts sufficient for the timely performance of this contract, the Contractor incurs additional costs or is delayed in the performance of the work under this contract, and if additional funds are allotted, an equitable adjustment shall be made in the price or prices (including appropriate target, billing, and ceiling prices where applicable) of the items to be delivered, or in the time of delivery, or both.
