

AMENDMENT OF SOLICITATION/MODIFICATION OF CONTRACT

The purpose of this modification is to provide an amount of \$16,978,420 in incremental funding, resulting in an extension of the funding coverage date to July 7, 2006. Accordingly, NNM04AA02C is modified as follows:

- A. Under Section B, Clause B.6, Contract Funding, the total amount allotted by the Government is increased by \$16,978,420, from \$407,322,351 to \$424,300,771. This amount will be added to the Estimated Cost line.
- B. The modification(s) made above are reflected in total on the change page(s) enclosed herewith. In order to reflect the change(s) made, the page(s) listed below are hereby deleted from, or added to, NNM04AA02C.
