- I. The purpose of this modification is to incorporate the requirements of Project Change Proposal (PCP) B81838C (NNM04AA02F portion only) entitled "TPS Mockup and Spray Facility – Design and Site Investigation for Installation of Plant Equipment." Pursuant to the provisions of Clause B.2, Estimated Cost for Facilities, Space Flight, Control and Data Communications, this modification adjusts the Negotiated Estimated Cost and Contract Value as set forth herein. This modification also updates Attachment J-2 to include B81838C (NNM04AA02F) and the Quarterly Reports for 2004 (3rd & 4th quarter) and 2005 (1st quarter).
- II. Section B. Clause B.2, Estimated Cost for Facilities, Paragraph (a) Space Flight, Control and Data Communications (SFC&DC), is hereby revised to increase the Negotiated Estimated Cost and increase Contract Value by \$250,643 as a result of negotiation of PCP B81838C (NNM04AA02F portion only). The new totals for Negotiated Cost and Contract Value for this paragraph are shown on the attached B-1 page.
- III. Section J, Attachment J-2, Contractor Acquired Property, is hereby revised to add Thermal Protection System (TPS) Mockup and Spray Facility – Design and Site Investigation for Installation of Plant Equipment associated with negotiated cost agreements related to Project Change Proposal B81838C.
