The purpose of this modification is to incorporate the requirements of Project Change Proposal (PCP) B81839K, entitled "Production Processing Facility Modifications -Construction of Facilities (CoF) –Line Item 368 – Rehab and Modify Building 103 New Gun/Proportioner Facility at MAF " in accordance with Section H, paragraph H.5, Construction of Facilities CoF Projects.
- II. Section B. Clause B.2, Estimated Cost for Facilities, (b) Construction of Facilities (CoF) Funds, is hereby amended to increase the Negotiated Cost and Contract Value by \$3,426,547. The new totals for Negotiated Cost and Contract Value for this paragraph are shown on the attached page.
- III. Attachment J-4, CoF Projects – Modification and Construction of Real and Installed Property, is amended to add Line Item # 368, Rehab and Modify Building 103 New Gun/Proportioner Facility.
- IV. It is mutually agreed that the contractor will not commence work on the scope incorporated with this modification until such time as the contract is modified to add funding in the amount of \$3,423,547 for this effort.
