

2. This modification revises Clause B.6, "Contract Funding" to add \$ 21,424 of incremental funding pursuant to the Limitation of Funds clause FAR 52.232-22. The estimated end date for funding coverage is extended from November 30, 2009 through January 15, 2010.
3. Accordingly, Clause B.6 Contract Funding is hereby revised to increase Estimated Cost by \$ 20,218 (from \$ 126,306,038 to \$ 126,326,256). Award Fee is hereby increased by \$ 784 (from \$ 5,141,845 to \$ 5,142,629), and Performance Incentive Fee is hereby increased by \$ 422 (from \$ 2,689,828 to \$ 2,690,250).
