

A. The purpose of this modification is to provide incremental funding in the amount of \$937,815.00 in accordance with contract clause B.6 (Contract Funding).

B. Accordingly, the allotted funding for the estimated cost is increased by \$884,925 (from 1,718,408.84 to \$2,603,333.84), the allotted funding for provisional cost incentive fee is increased by \$13,222 (from \$32,336 to 45,558), and the allotted funding for provisional performance incentive fee is increased by \$39,668 (from \$97,007 to \$136,675). Thus, the total allotted funding for the contract is increased by \$937,815.00 (from \$1,847,751.84 to \$2,785,566.84).

C. Therefore, the contract is changed in the following particulars:

Section B, Clause B.6, CONTRACT FUNDING, is hereby deleted in its entirety and the revised Clause B.6, shown on the enclosed replacement page B-7, is substituted in lieu thereof.

(g) *Inconsistencies.* In the event of any language inconsistencies between this clause and the provisioning documents or Government options under this contract, compensation for spare parts or other supplies and services ordered under such documents shall be determined in accordance with this clause.

B.6 CONTRACT FUNDING (NFS 1852.232-81) (JUN 1990)

(a) For purposes of payment of cost, exclusive of fee, in accordance with the Limitation of Funds clause, the total amount allocated by the Government to this contract is \$2,603,333.84. This allotment is for the Office of Strategic Analysis and Communications Support Services effort described in Attachment J-1, Performance Work Statement, and covers the following estimated period of performance: April 01, 2007 – August 26, 2007.
